
# REGIONAL CONFERENCE THURSDAY 23RD NOVEMBER 2023

Hi from Doncaster's Safeguarding Partnership's Business Unit

The business unit support the Joint Safeguarding Partnership, DSCP, and DSAB boards to ensure that multi-agency and partnership work in Doncaster is effective. Remembering that Safeguarding is Everyone's Business we work closely with key partners - police, the local authority including social care, health agencies, education organisations such as schools, as well as the community and voluntary sector - to be assured that children and adults are effectively safeguarded.

The work of the Partnership is supported by a number of sub-groups, and other working groups, made up from representatives from a wide range of agencies to ensure that the partnership collectively is meeting it statutory responsibilities and progressing identified priorities all to ensure children and adults within Doncaster are effectively safeguarded when they need to be. Our priorities currently include progressing the priorities identified to children. adults and their families regarding neglect, self-neglect, child explotation, and young adults transitioning from children to adult services.

In addition to this the Partnership leads on the completion of learning reviews (Child Practice Learning Reviews and Safeguarding Adult Reviews) where it is felt there is some learning for multiagency working across the partnership.

"Hi, I am very pleased to introduce myself as the independent chair and scrutineer for the Doncaster Safeguarding Children Partnership. I come to this role with over 30 years' experience in children's services, ranging from residential social worker through to senior management roles in both the voluntary sector and local government. What this experience has taught me, above all else, is that if we want to make a difference for children and their families it has to be in partnership: partnership with the child/ young person, partnership with the family members and partnership with our colleagues across all the services supporting children. For the sake of our most vulnerable children and young people, those at increased danger of neglect and abuse both within the family and from outside, we must strive to continue to work together."

#### **DSCP Independent Chair and Scrutineer - Dot Evans**

"Following the privatisation of the Nottinghamshire Probation Service, of which I was CEO of, I decided to develop a portfolio of paid and unpaid work.
