Thank you for your Environmental Information Regulation request dated 14 August 2023 for information about EV charge points on grade 2 listed buildings. Please find below City of Doncaster Council's responses to the questions you have raised.

1. Have you approved installation of EV (electrical vehicle) charge points for any grade 2 listed buildings and if so, how many in the last five years?

Response: If someone wishes to install an EV charging point on a grade 2 listed building they would need to apply for permission, whether through a planning application or listed building consent.

Regulation 6(1)(b) of the Environmental Informaion Regulation allows for authorities to not provide information if it is already available to the applicant in another format, for example via a website. In this instance, the information about planning applications can be accessed via City of Doncaster Council's website at https://www.doncaster.gov.uk/planningapplicationsonline.

A variety of keyword searches can be conducted to retrieve applications relating to electrical charging points. As a suggestion: electrical vehicle, charging and charger. If this search is conducted under the 'Advanced' tab you can also stipulate the Decision Date between the last five years. Based on the results the address of the proposal can be cross referenced with our Listed Building Map which will flag if that property is a grade 2 listed building: Listed buildings in Doncaster - City of Doncaster Council

It will state in the application detail overview whether planning permission was approved or refused.

2. Did you require any of those approved to submit a listed building consent application, again if so, how many of them?

3. Of those approved EV charge points for grade 2 listed buildings was a planning application required, if so, how many?

Response: Approval is given by submitting a planning application or listed building consent application, therefore this question is answered under question 1.

4. Of those approved did you stipulate the kind of EV charger, size, made, model etc and if so, what were those stipulations.

Response: The City of Doncaster Council does not have a policy stipulating EV chargers to be used, size, make, model etc. The Local Planning Authority determines the application based on the details submitted by the applicant.

5. How many EV charge points have you **not** approved, in the last five years, for grade 2 listed buildings?

As per response to Question 1, the number of applications not approved will be revealed through this search criteria.
