Please find below City of Doncaster Council's responses to the questions you have raised.

## Request:

"I am a journalist at ITV National News. I am contacting you with a request for information under the Freedom of Information Act 2000. My request relates to the number of complaints about aesthetic procedures in your local authority area.

### **Definition of terms:**

- We are defining 'aesthetic procedures' as non-surgical, cosmetic treatments. For example: filler injections, liquid Brazilian butt lifts, lipo reduction, liposuction, Botox and non-surgical/filler breast implants.
