Thank you for your Freedom of Information request dated 7 April 2024 for information about traffic-reducing schemes. Please find below City of Doncaster Council's responses to the questions you have raised.

Response: No low traffic neighbourhoods have been delivered in Doncaster, an allocation was awarded to deliver an Active Neighbourhood within Active Travel Fund 2 but this was not actioned. There have been 27 active travel schemes funded by a range of external funding sources between January 2020 and 16<sup>th</sup> April 2024. These include.
