Thank you for your Freedom of Information request dated 9 January 2024, for information about electric charge point access for disabled/motability drivers.

Please find below City of Doncaster Council's responses to the questions you have raised.

Q1. How many electric vehicle public charging outlets or chargepoints have you installed in your local authority to date that are classed as on-street residential chargepoints, located in residential streets or areas? Please provide figures to the nearest possible date and include the month and the year the figures correspond to.

Response:

No onstreet residential chargepoints have been installed. However, 100 are proposed for installation in 2024.

Not applicable. However, the design for the 100 chargepoints will be compliant with PAS1899 where possible.

Response:

The cost to use Council owned EV chargepoints are the same for all users

Response:

Yes. Public chargepoints owned by the Council are registered and identifiable through zapmap and City of Doncaster Council's website.
