This report provides an update to the Medium-Term Financial Strategy in paragraphs 169-172. This update builds on the Council's budget report from February 2023, which is available online by clicking the following link:

The budget report identified cumulative funding gaps of £7.6m in 2024/25 and £22.3m in 2025/26 (details in paragraphs 33 to 38) and went on to identify savings to fill that gap, resulting in a balanced position (details in paragraphs 39 to 48).

The next quarterly monitoring in-year position update is due to be reported to Cabinet on 7th February 2024.
