Thank you for your Freedom of Information request dated 25<sup>th</sup> May 2025 for information about housing associations. Please find below City of Doncaster Council's responses to the questions you have raised.

**Question 1:** A list of all organisations, housing associations, and private providers currently commissioned, contracted, or funded by Doncaster city Council to provide:

- Emergency accommodation (including for homeless individuals, families, asylum seekers, rough sleepers, and other vulnerable groups);
- Assisted living or housing with adaptations for people with disabilities, mobility needs, or chronic medical conditions;
- Supported living or housing with support for individuals with mental health needs, learning disabilities, substance misuse issues, young care leavers, or other special requirements.

**Question 2:** For each organisation, please provide where available:

- Name and contact details (including email or phone if available)
- Type of service provided (emergency, assisted, supported, etc.)
- Target client group(s)
- Whether the accommodation is funded through council contracts, housing benefit (including exempt accommodation status), or other schemes
- The number of units or beds they currently manage within the Doncaster city boundary

**Question 3:** Please also include:

- Any framework, panel, or preferred provider list that the council uses for commissioning supported accommodation or temporary housing;
- Details of any schemes or departments within Doncaster city Council responsible for placing individuals in such accommodation;
- Any guidance or policies that indicate whether Doncaster city Council or its partners are permitted to pay above Local Housing Allowance rates in certain circumstances (e.g., exempt accommodation, intensive housing management, or specialist needs housing).

**Response:** This information is exempt from disclosure under Section 'a021 of the Freedom of information Act. Section 21 exempts information from the 'a0right of access if that information 'a0is reasonably accessible to the applicant by other means.
