Thank you for your Freedom of Information request dated 10<sup>th</sup> June 2025 for information about school attendance enforcement. Please find below City of Doncaster Council's responses to the questions you have raised.

## Response:

Section 12 (1) of the Freedom of Information Act allows for a request for information to be refused where the cost of supplying this information exceeds the appropriate limit. After carefully considering your request for information the City of Doncaster Council has decided that to respond to your request would exceed the appropriate limit as defined in the Freedom of Information (Appropriate Limit and Fees) Regulations 2004. The regulations allow a request for information to be refused where the cost of supplying this information exceeds £450 (or 18 hours of officer time).

The cost limit applies in this case because the City of Doncaster Council does not hold a central record of this information and in order to determine penalty notices issued in relation to school attendance in 2023/24, as per column L of the attached spreadsheet, how many were in relation to pupils who had an Education, Health and Care a total of 684 cases will need to be reviewed. It is estimated that each case will require a 10-minute investigation. As details of 684 cases require review in order to determine this information this would result in a total time of approximately 114 hours which would exceed the time limit.

In order for us to reconsider your request we ask that you make your request more specific by narrowing down the scope of your request. For example, we can answer question 1 to 3 within the time limit. If you would like to make a request for this information please respond to this email address.

City of Doncaster Council estimates that it has cost £49.00 to respond to this request for information.

The information concerns parental responsibility measures in the 2023/24 academic year, based on figures provided by local authorities in the parental responsibility measures attendance census (referred to henceforth as "the census").

My request relates directly to the figures provided by the council in response to this census, and subsequently published by the Department for Education. A spreadsheet containing relevant figures is attached, and my questions will refer to the spreadsheet.
