Response:

Section 12 (1) of the Freedom of Information Act allows for a request for information to be refused where the cost of supplying this information exceeds the appropriate limit. After carefully considering your request for information the City of Doncaster Council has decided that to respond to your request would exceed the appropriate limit as defined in the <u>Freedom of Information (Appropriate Limit and Fees) Regulations 2004</u>. The regulations allow a request for information to be refused where the cost of supplying this information exceeds £450 (or 18 hours of officer time).

The cost limit applies in this case because the City of Doncaster Council does not hold a central record of this information and to determine business rates in respect of all non-domestic properties within the billing authority, a total of 9823 records will need to be reviewed. It is estimated that each record will require a 15 second investigation, resulting in a total time of approximately 40 hours, which would exceed the time limit.

City of Doncaster Council estimates that it has cost £49.00 to respond to this request for information.
