Thank you for your Freedom of Information request dated 18th March 2025 for information about Early Years Advisors. Please find below City of Doncaster Council's responses to the questions you have raised.

Request 1: The names, job titles, email addresses, and phone numbers of all Early Years Advisors within your local authority.

Response:

The names, personal email addresses and telephone numbers for individual Early Years staff is exempt from disclosure under Section 40(2) of the Freedom of Information Act 2000. The information requested is third party personal data (i.e. personal data about someone other than you). 'a0Section 40 (2) provides that information which is third party personal data is exempt from disclosure if one of three conditions is satisfied. In this case the following condition applies:

1. Disclosure would contravene one of the data protection principles

The details you have requested regarding council officers are personal data. 'a0Disclosure of the information would contravene the requirement in principle 1 that personal data must be processed fairly and lawfully. 'a0As an employer the City of Doncaster Council owes a duty of confidence to employees and the employee has not consented to the disclosure of this information. 'a0Disclosing details without the consent of Officer would breach that duty of confidence and be unlawful. 'a0We therefore are unable to provide the requested information at this time.
