# Dear

Thank you for your Freedom of Information request dated 10<sup>th</sup> March 2025 for information about looked after children. Please find below City of Doncaster Council's responses to the questions you have raised.

Question 1: How many children are looked-after by the local authority?

Response: There are currently 513 looked-after children under the City of Doncaster Council.

**Question 1a:** How many of these children are looked-after as a result of or because they were at risk of abuse or neglect?

Response: 351 of these looked after children are a result of or because they were at risk of abuse or neglect.

**Question 1b:** How many of these children are looked-after due to the parent's disability or illness? **Response:** 7 of these looked after children is due to the parent's disability or illness.

**Question 2**: How many children that are looked-after by the local authority have a neurodevelopmental diagnosis? Neurodevelopmental diagnoses in this case refer to diagnoses of attention deficit/ hyperactivity disorder (ADHD, ADD), autism (autism spectrum disorder, Asperger's) and chronic Tics or Tourette's (Tourette syndrome, Tic disorder).

**Response:** There are 16 looked after children by the City of Doncaster Council that have a neurodevelopment diagnosis.

**Question 2a:** How many of these children are looked-after as a result of or because they were at risk of abuse or neglect?

**Response:** 7 of these children are looked after as a result of or because they were at risk of abuse or neglect.

**Question 2b:** How many of these children are looked-after due to the parent's disability or illness? **Response:** 0 of these children are looked after due to the parent's disability or illness.

**Question 3:** How many children that are looked-after by the local authority have a diagnosis of attentiondeficit/hyperactivity disorder (ADHD, ADD)?

Tic disorder/ Tourette syndrome? **Response:** The virtual school head has never reported to the corporate parenting board on the numbers and needs of looked after children with a diagnosis of ADHS Autism, Tic disorder/Tourette syndrome.
