Thank you for your Freedom of Information request dated 8 April 2025 for information about Looked After Children moving schools/placements. Please find below City of Doncaster Council's responses to the questions you have raised.

1. Between 1st September 2023 and 31st August 2024, how many Looked After Children in academic Year 10 for whom your Local Authority is the corporate parent:

Moved from one placement to another; = 47

Moved from one school to another school; = 6

2. Between 1st September 2023 and 31st August 2024, how many Looked After Children in academic Year 11 for whom your Local Authority is the corporate parent:

Moved from one placement to another; = 66

Moved from one school to another school; = 15

3. Between 1st September 2023 and 31st August 2024, how many Looked After Children in academic Year 12 for whom your Local Authority is the corporate parent:

Moved from one placement to another; = 88

Moved from one school to another school; = 7

4. Between 1st September 2023 and 31st August 2024, how many Looked After Children in academic Year 13 for whom your Local Authority is the corporate parent:

Moved from one placement to another; = 104

Moved from one school to another school; = 5

5. Between 1st April 2024 and 30th June 2024, how many Looked After Children:

In academic Year 11, for whom your Local Authority is the corporate parent, moved from one school to another; = 1

In academic Year 11, for whom your Local Authority is the corporate parent, moved from one placement to another; = 58

In academic Year 13, for whom your Local Authority is the corporate parent, moved from one placement to another; = 36

In academic Year 13, for whom your Local Authority is the corporate parent, moved from one school to another school; = 2

In academic Year 13, for whom your Local Authority is the corporate parent, left care (ceased to be a Looked After Child). = 24
