The below answers are for School Catering. School milk is organised by schools themselves. No dairy milk or cream is used for other purposes.

1. How many litres of dairy milk do you use in 2023 ? Response: 28,440 litres

2. What is the approximate percentage split for dairy milk Response: Semi Skimmed Dairy Milk 97%, Whole Dairy Milk 3%

3. Are you using more/less dairy milk currently than you did last year ? And Why ? Response: Less milk as we have fewer schools in our contract.

4. How is the milk that you use packaged and what is the approximate percentage breakdown by packaging

Response: Poly bottle 2 litres 100%

5. How many litres of dairy cream do you use in 2023 ? Response: Very little – 40/50 litres if we do buffets.

6. Are you using more/less dairy cream currently than you did last year ? And Why Response: This information is not held.

7. What is the approximate percentage split for dairy cream Response: Aerosol Dairy Cream 40%, Whipping Cream 60%

8. How is the dairy cream that you use packaged and what is the approximate percentage breakdown by packaging

Response: Plastic tub 907gm 60%, Aerosol 500gm 40%

9. From where do you purchase your dairy milk and cream ? Response: Since September 2023 contract awarded to Paynes Dairy Foodservice

10. Over the next 5 years are you likely the change the way in which you purchase any of the following products ?
