All statutory consultees were in favour of renewing the PSPO as it stands with the Ward Members, Highways, Enforcement & St Leger Homes colleagues also in favour of the new requirement around Bins. SYP & PCC however had reservations about this and made comments accordingly.

Who is the target audience?	<p>The target audience for potential PSPO renewal will be residents of Hexthorpe and those that have a vested interest there, businesses and any wider stakeholders. <p>Consultation Analysis - What did the consultation tell us?</p> <p><i>Background - Public Space Protection Order (Anti-Social Behaviour, Crime and Policing Act 2014)</i></p> <p>The project / policy under consideration is the renewal of the Hexthorpe Public spaces Protection Order (PSPO) for a further 3 years from 10 August 2024. The current Hexthorpe PSPO has been in place since August 2015 with prohibitions covering anti-social activity in a designated area covering the Hexthorpe area.</p> <p>A Public Space Protection Order (PSPO) is an order that identifies a public place and prohibits specified things being done in the restricted area and/or requires specified things to be done by persons carrying on specified activities in that area.</p> <p>A PSPO is made by a Local Authority if satisfied on reasonable grounds that two conditions are met. Firstly, that (i) activities carried on in a public place within the authority's area have had a detrimental effect on the quality of life of those in the locality; and (ii) it is likely that activities will be carried on in a public place within that area and that they will have such an effect.</p> <p>The second condition is that the effect, or likely effect, of the activities is, or is likely to be of a persistent or continuing nature, such as to make the activities unreasonable, and therefore justifies the restrictions imposed by the notice.</p> <p>The Council carried out a public consultation between 15th January 2014 and 10th March 2024 on the future of the Hexthorpe PSPO and whether it should be varied and extended. The outcome of the consultation is that there is overwhelming support for the renewal of the existing prohibitions and addition of the new requirement from residents, businesses and key stakeholders. There was a total of 368 people who completed the survey for the purpose of this return. This figure far exceeds the previous renewal of 148 returns.</p> <p>The current PSPO has seven prohibitions, questions were asked about each prohibition and the suggested proposal for the new requirement about waste presentation. The results of the online survey are a complete representation of all responses received.</p>	

The activity a renewed PSPO will cover and prohibit / require is, as follows -

1. No congregating in a group of 3 or more people which is behaving in a manner which is causing or is likely to cause any person harassment, alarm or distress.
2. No person shall engage in games on the public highway in a way that causes a nuisance or annoyance to those living nearby in the area.
3. No person shall make any excessive noise so as to cause a detrimental effect on the quality of life of those in the locality.
4. No person shall enter the play area on Urban Road, Hexthorpe between the hours of 21:30pm and 07:00am.
5. No person shall consume alcohol in any public place in Hexthorpe other than at licensed premises.
6. No person shall be in possession of any opened vessel containing or purporting to contain alcohol in any public place save for those places identified by Section 62 of the Act
7. No person will ingest, inhale, inject, smoke or otherwise use intoxicating substances (substances with the capacity to stimulate or depress the central nervous system) or possess any item that can be used to assist in the taking of intoxicating substances. This includes any device for smoking substances other than e-cigarettes, it also includes needles, except for those packaged and sealed by the manufacturer and stored in a hard case.
8. (Requirement) Each relevant person must ensure that all household waste presented for collection from their premises is contained in a wheelie bin or is presented for collection in a manner specified for their property by City of Doncaster Council. In addition each relevant person must ensure that the wheelie bin for their property or waste presented for collection in a manner specified for their property is not situated outside the boundary of their premises other than between 6pm on the day before collection is due, and 9pm on the day of collection.

In addition to the specific prohibitions and requirement we gave people three options of how they would like to see the order progress and as you can see below **87.2% of those that responded wanted to extend the current PSPO with the addition of the requirement for presentation of refuse containers (Option1).**

Summary - Option One, the proposed PSPO with the addition of the requirement for refuse container presentation will continue to act as an additional measure to complement the existing Council and public service partnership aim to provide support to people, alongside strengthened support systems in place across agencies with information, advice, guidance. Within the order it is clearly outlined when the prohibitions are to be in place and available for use. Officers using the powers within the order will make the informed decision on a case-by-case situation through use of clear engagement and taking into account any valid exemptions such as disability and / or medical related emergencies and in particular those linked to the prohibition around 'ingest, inhale, inject, smoke or otherwise use substances' which clearly states - 'Exemptions shall apply in cases where the substances are used for a valid and demonstrable medicinal use, given to an animal as a medicinal remedy, are cigarettes (tobacco) or vaporisers or are food stuffs regulated by food health and safety legislation.

All designated officers with the responsibility to enforce the prohibitions within the order are trained in equality and diversity from induction and this is updated on a regular, if not annual basis. These include officers within Doncaster Council and officers from South Yorkshire Police. If approved by Cabinet, it is proposed that the PSPO will implemented on the 10th August 2024 as the current PSPO is due to expire on the 9th August 2024 following the expiry of the necessary call-in period. The activity a renewed PSPO will require and prohibit is as follows:

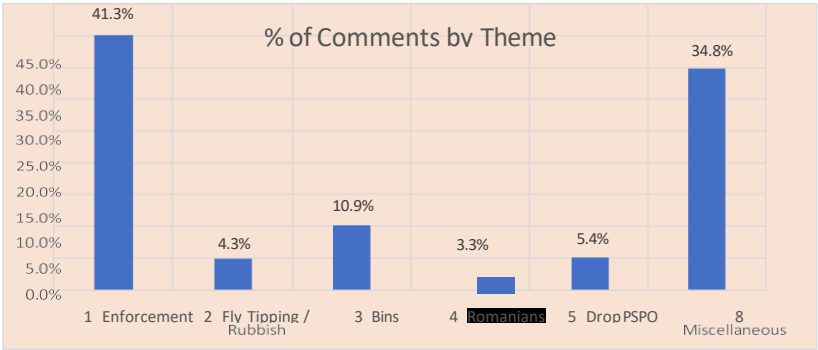
1. **Congregating** - No congregating in a group of 3 of more people which is behaving in a manner which is causing or is likely to cause any person harassment, alarm or distress.
2. **Street Games** - No person shall engage in games on the public highway in a way that causes a nuisance or annoyance to those living nearby in the area.
3. **Noise** - No person shall make any excessive noise so as to cause a detrimental effect on the quality of life of those in the locality.
4. **Play Area (Mutual street)** - No person shall enter the play area on Urban Road, Hexthorpe between the hours of 21:30pm and 07:00am.
5. **Alcohol** - No person shall consume alcohol in any public place in Hexthorpe other than at licensed premises.
6. **Alcohol** - No person shall be in possession of any opened vessel containing or purporting to contain alcohol in any public place save for those places identified by Section 62 of the Act
7. **Intoxicating Substances** - No person will ingest, inhale, inject, smoke or otherwise use intoxicating substances (substances with the capacity to stimulate or depress the central nervous system) or possess any item that can be used to assist in the taking of intoxicating substances. This includes any device for smoking substances other than e-cigarettes, it also includes needles, except for those packaged and sealed by the manufacturer and stored in a hard case.
8. **Waste Presentation (Requirement)** - Each relevant person must ensure that all household waste presented for collection from their premises is contained in a wheelie bin or is presented for collection in a manner specified for their property by City of Doncaster Council. In addition each relevant person must ensure that the wheelie bin for their property or waste presented for collection in a manner specified for their property is not situated outside the boundary of their premises other than between 6pm on the day before collection is due, and 9pm on the day of collection.

Enforcement

Many comments express concerns around feeling safe when in the area and also about the ability of all agencies to enforce the public space protection order. Some of those comments are detailed below for information.

- Rules need to be taken seriously by residents, so prosecutions should always apply. Certain areas are no go areas! Such a pity.
- We need the resources to enforce the PSPO otherwise it is not effective just an order on paper.
- Need more enforcement music is really bad.
- It's all being well having a PSPO but when you have council employed people in CCTV vans driving past obvious contraventions of the rules and doing absolutely nothing to enforce it, it just makes it an absolute joke.
- All available powers should be in play to ensure the authorities can address all forms on unacceptable behaviour.
- I grew up in Hexthorpe in the 60s and 70s it was safe place... it is no longer a safe place and new regulations, and more police need to be in place.
- There needs to be a visible police presence in this area especially around [REDACTED] and the other side streets.

The purpose of the proposed renewal of the public space protection order is to address these enforcement issues and ensure that the area is somewhere everyone can live work and visit without feeling intimidated. There is a multi-agency plan in place for enforcement of the order and this includes South Yorkshire Police and city of Doncaster Council staff and its partners.

Bins

Other comments were made in relation to the bin collection service and general waste and recycling issues. Some of those comments are detailed below for information.

- *Would like it extended Doncaster wide. Did not realise when started that this was only about Hexthorpe! But lots of other areas have same issues - especially bins*
- *The longer the bins are out the more chance they have of being stolen.*
- *I'm a wheelchair user and find bins left out on pavements longer than necessary a real hazard.*
- *To prevent bin theft, Council should clearly stencil the house numbers on the bins.*
- *The wheelie bin issue should be across all of Hexthorpe not just the bottom end.*
- *Bins out after pick up day - fine them straight away*
- *If the refuse containers are removed in a reasonable time frame, then maybe it could help to discourage (1) other people using someone else's bin for their rubbish. (2) eases access to the rear of our property.*
- *All Hexthorpe for the bins please*
- *In relation to emptying and placement of bins for collection. Due to the council not effectively managing their collections of bins on the scheduled days and with my household being in full time employment this can mean that bins are outside the property outside of the scheduled collection days and times. If a bin is not emptied or the scheduled run does not take place the council can be vague with their response regarding when to put out the bin for collection.*

The City of Doncaster Council's enforcement and waste and recycling teams will have in place a schedule to deal with this issue should the public space protection order be renewed and the new requirement be in place.

Fly Tipping / Rubbish & Littering

Further comments were made in relation to the widespread issues of fly tipping littering and rubbish in general. Some of those comments are detailed below for information.

- *the proposed additional PSPO clause will help the amount of fly tipping, vermin and litter in the Hexthorpe area.*
- *More needs to be done with the fly tipping. Its all good the council coming and cleaning the streets. It lasts for like a day and goes back to the norm. Please educate people. The more the council clean up, the more mess they make. They know that whether it takes one day, one week or one month the council will come back to clean and so repeats the cycle. Also who's idea was it to run a main road at the back of peoples back gardens. [REDACTED] town end is an eye sore. The back gates are falling into disrepair.*
- *People have no respect for where they live. Can there not be some large bushes be planted alongside the path to at least make it more pleasing on the eye. Also a rubbish bin will now be need at the top of [REDACTED] with the new shop opening and also with kids going [REDACTED] then onto school, they have eaten the sweets by the time they reach [REDACTED] and the rubbish gets thrown on the floor. A bin would help. Also some people obviously can't remember their driving test as they literally park across the junction on [REDACTED] [REDACTED] to go shop. Maybe some yellow lines. Could be enforced when going round at school times, first thing in a morning or evening. The council would earn a fair amount in fines.*

- *Sort out dumping of rubbish and clamp down on people having fires in gardens every day*
- *Keeping pavements clear would help develop pride in an area*
- *Messy area. Awful culture and environment there it devalues Doncaster as an area*

The city of Doncaster Council already has powers to deal with many of the issues raised under this heading. We are working with partners to ensure that all issues related to fly tipping and littering are enforced and as importantly that all members of the public are educated regarding these issues that blight many of our communities. Hexthorpe has seen the largest number a fixed penalty notices issued for an area of its size outside of the city centre and the number of enforcement cases for this type of activity is again the highest for a residential area in the city.

Miscellaneous

Finally, there were several miscellaneous comments that could not be categorised within the headings above but again they give a general feeling of how people think and what matters to them as residents of the area. Some of those comments are detailed below for information.

- I feel the ball games one should allow young children to play outside their homes if supervised.
- You do not accommodate for people who are in employment.
- In my area the PSPO has helped. In the last year I have a sense that it has improved on the way into the city.
- It's not working, walk around Hexthorpe and find out for yourselves.
- Q8. this one should be extended to the whole of Hexthorpe and not just one part as we have people play music and other loud noise through the night till early morning.
- Hexthorpe needs to be a friendly local community where people can visit the park. Walk their dogs and go about their business in safety.
- 3 or more is not enough it should be 6 or more.
- Really bad kids are worse I'm tired all the time.
- Noise is very bad, needs to stop - keeps me up.
- I don't care either way.
- Change 3 to any person,
- Kids are ok it's adults that are the problem
- Get the under 18 in by 10 after that they are up to no good
- I don't think the PCSO are truly doing their jobs and a couple stated a waste of time.
- Put gates on rear of [REDACTED] to stop people coming round entering or looking into gardens, drinking in alley way discarding cans and bottles into garden's, Drug user's on cycles and cars distributing their drug's selling and using alleys as toilets and dumping of household goods
- Could you add prohibitions such as - to not to harass or cause distress to anyone. This covers all forms of anti-social activity. This is could be more useful than gathering in groups of three or more. Also, vehicle nuisance is a problem, so could we have a prohibition please on nuisance vehicles - People not to engage in, promote, encourage or assist in the carrying out of antisocial behaviour connected to the use of cars and other vehicles. This relates to pavement parking, blocking access, blocking streets, inconsiderate driving and noisy vehicles, loud music from vehicles etc.
- My first summer here let's see how it goes.
- Very big problem I don't sleep.

- Is a problem in summer.
- These PSPO are supposed to be a temporary measure when dealing with a problem in an area. It seems they are now becoming a norm and are becoming a permanent fixture. How then can you check on a development regarding the issue. Not all the public need to be painted with the same brush. Deal with a problem when it arrives.
- publish results of how many tickets have been issued more.
- Hexthorpe is a shithole. not much point fining them for them to end up paying a pound a week out of their benefits tho. It needs tougher measures to tackle that! Try investigating all of the fake barber shops that are just a front for cleaning all the money made by crime!
- Invest in artists residencies with partners such as Art Bomb to do more engagement through Stealth and education.
- Messy area. Awful culture and environment here it devalues Doncaster as an area.
