**PUBLIC FOOTPATH NO. 3 (PART) AND NO. 7 BARNBURGH
CREATION ORDER 2025**

This Order is made by City of Doncaster Council ("the authority") under section 26 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that, having regard to the matters set out in section 26(1), there is a need for public footpaths over the land to which this order relates, and that it is expedient that the paths should be created.

BY THIS ORDER:

1. There shall be from the date of confirmation of this order public footpaths over the land at Barnburgh described in the Schedule to this order and shown by a bold broken line on the map attached to this order.

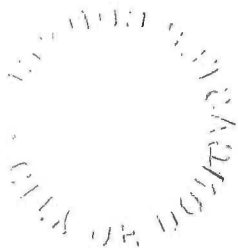

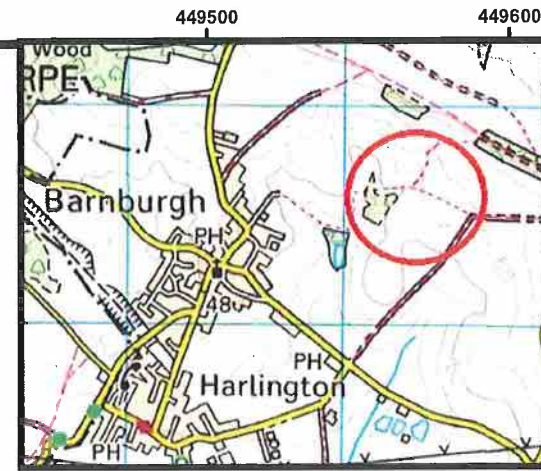
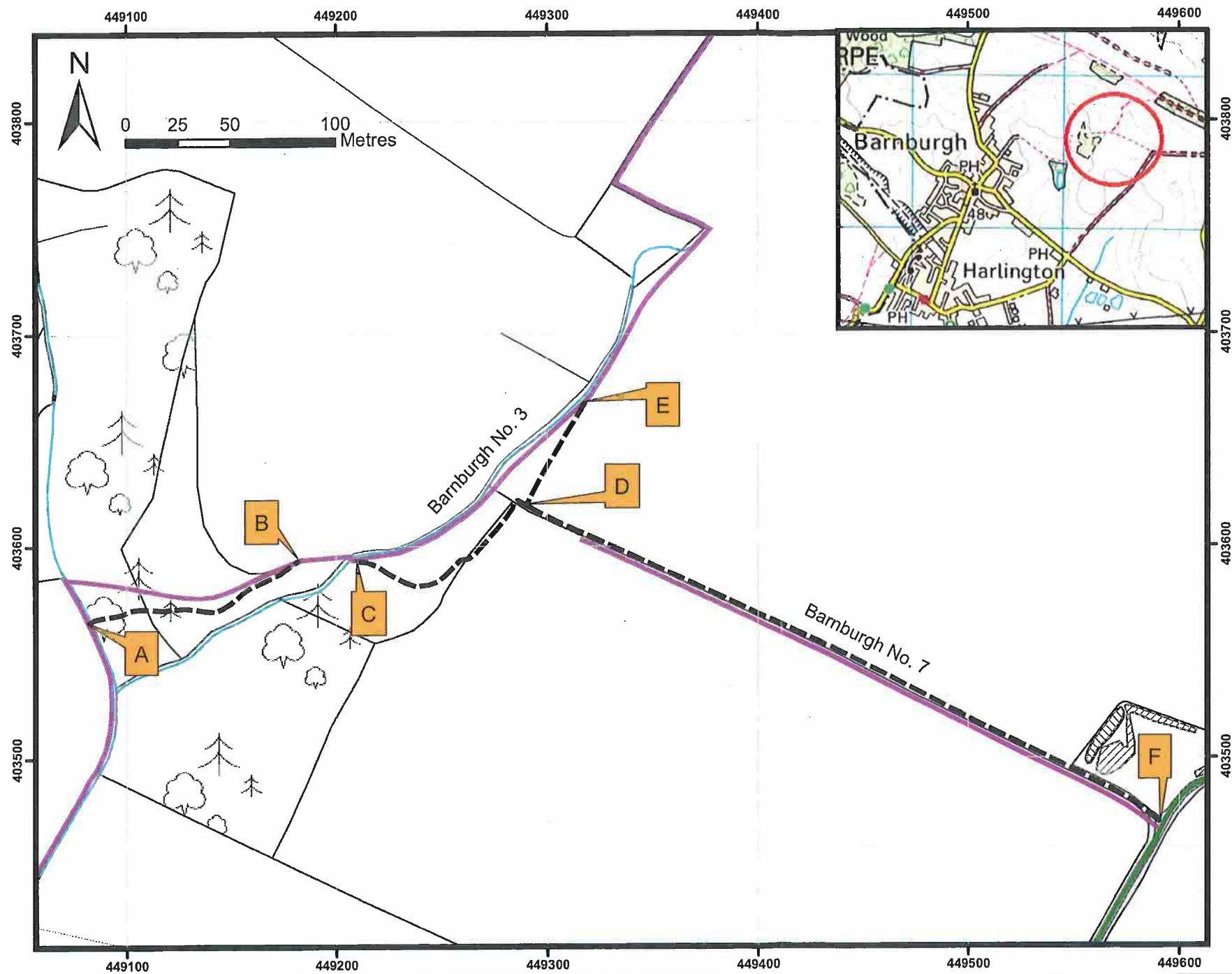
DESCRIPTION OF LAND

A footpath with a width of 1 metre commencing from Barnburgh footpath no. 3 at grid reference SE 4908 0356 (point A on the order map) and proceeding generally east-north-easterly through the wood for some 109 metres to rejoin Barnburgh footpath no. 3 at grid reference SE 4918 0359 (point B on the order map).

A footpath with a width of 1 metre commencing from Barnburgh footpath no. 3 at grid reference SE 4921 0359 (point C on the order map) and proceeding east-south-easterly then north-easterly through the wood for some 60 metres, thence continuing along the field boundary for some 36 metres before turning east-south-easterly along the boundary of the next field for some 6 metres to grid reference SE 4929 0362 (point D on the order map), thence heading north-north-easterly for some 58 metres to rejoin Barnburgh footpath no. 3 at grid reference SE 4932 0367 (point E on the order map).

A footpath with a width of 1 metre commencing from Barnburgh footpath no. 3 at grid reference SE 4929 0362 (point D on the order map) and proceeding east-south-easterly along the field boundary for some 337 metres to Barnburgh bridleway no. 4 at grid reference SE 4959 0347 (point F on the order map).
