**DONCASTER BOROUGH COUNCIL PUBLIC FOOTPATH NO 6
ADWICK LE STREET (PART) ORDER 2020
VARIATION ORDER 2025**

This Order is made by City of Doncaster Council under section 333(7) of the Town and Country Planning Act 1990.

BY THIS ORDER:

1. The Doncaster Borough Council Public Footpath No 6 Adwick le Street (Part) Order 2020, confirmed with modifications on 22nd October 2021, is hereby varied:

(a) The map dated 28th February 2020 attached to the 2020 order shall be deleted and substituted with the map dated May 2025 attached to this order.

(b) In the opening paragraph the words 'and unrecorded path' shall be inserted after 'footpath'.

(c) In paragraph 1 the words 'and unrecorded path' shall be inserted after 'footpath'.

(d) In paragraph 2 the words 'and unrecorded path' shall be inserted after 'footpath'.

(e) In the SCHEDULE PART 1 Description of site of existing path or way, all three lines shall be deleted and substituted with:

'The full width of a section of Adwick le Street footpath no. 6 commencing from grid reference SE 5270 0781 (point A on the order map) and proceeding west-north-westerly for some 186 metres to grid reference SE 5252 0786 (point B on the order map).'

'The full width of unrecorded path commencing from grid reference SE 5263 0783 (point C on the order map) and proceeding westerly for some 113 metres to grid reference SE 5252 0785 (point D on the order map).'





2. This order shall come into effect on the date it is confirmed and may be cited as the Doncaster Borough Council Public Footpath No 6 Adwick le Street (Part) Order 2020 Variation Order 2025.


