**PUBLIC FOOTPATH NO. 5 BARNBURGH
EXTINGUISHMENT AND DEFINITIVE MAP MODIFICATION ORDER 2025**

This Order is made by City of Doncaster Council ("the authority") under section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that the footpath described in paragraph 1 below is not needed for public use.

This order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that The County of the West Riding of Yorkshire (Area 3) definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the stopping up (as authorised by this order) of a highway hitherto shown or required to be shown in the map and statement.

BY THIS ORDER:

1. The public right of way over the land situate at Barnburgh and shown by a bold continuous line on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up from the date of confirmation of this order, and thereupon The County of the West Riding of Yorkshire (Area 3) definitive map shall be modified by deleting from it that public right of way, and the definitive statement shall be modified as described in Part 2 of the Schedule to this order.
2. For the purposes of this order the relevant date is the date upon which the order comes into effect.

PART 1

Description of Public Right of Way Extinguished

The full width of Barnburgh footpath no. 5 with a length of 1650 metres commencing from Harlington Road at grid reference SE 4891 0263 (point A on the order map) and proceeding southwards to the beck then eastwards through Barnburgh Grange Farm to Melton Mill Lane at grid reference SE 4990 0177 (point B on the order map).
