PUBLIC SPACE PROTECTION ORDER FOR DOG FOULING AND CONTROL

The original Dog fouling and control Public Space Protection Order (PSPO) was authorised in February 2017 for a period of 3 years following a borough wide consultation. Throughout the life of the previous order there has been both enforcement and engagement work undertaken. This included media campaigns with young children included for a poster design to highlight the issue, and targeted education around general waste and litter issues delivered by Doncaster Council's Waste and Recycling team within schools and to community groups. A PSPO consultation process started on 18 December 2019 with statutory and specific consultees, 20 December 2019 with residents of Doncaster and ceasing the consultation period on 2 February 2020. Overall the consultation results demonstrated a very strong level of support for each of the proposed prohibitions. On 10th March 2020 Cabinet approved an extension to the Public Space Protection Order for a further 3 years.

In September 2022 it was felt that although there had been a small decrease in the number of complaints relating to dog fouling and control in the Doncaster area over the past three years, there was a need to further consult the public and statutory partners on a further renewal of the order. Therefore, in September 2022 a 10-week public consultation took place ending in November 2022. Once again the overall consultation results demonstrated a strong level of support for each of the proposed prohibitions. On the 15th February 2023 Cabinet approved a further 3 year extension of the order.

What is a Public Space Protection Order?

Public Spaces Protection Orders were introduced by the Anti-Social Behaviour Crime and Policing Act 2014. A Local Authority can make such an order if it's satisfied on reasonable grounds that activities carried out in a public place within the authority's area have had a detrimental effect on the quality of life of those in the locality, or it's likely that activities will have such an effect. And that the effect, or likely effect of the activities is, or is likely to be, of a persistent or continuing nature, or is likely to be such as to make the activities unreasonable, and justifies the restrictions imposed by the notice.

The conditions of each PSPO are tailored to give Local Authorities and the Police the necessary and proportionate powers to tackle the problems occurring, or likely to occur, within the area.

ANTI-SOCIAL BEHAVIOUR, CRIME AND POLICING ACT 2014
PUBLIC SPACE PROTECTION ORDER

The City of Doncaster Council (“the Council”) has exercised its powers under the Anti-Social Behaviour, Crime and Policing Act 2014 ("the Act") and hereby makes a Public Space Protection Order for Dog fouling and Control city wide.

1. This Order shall come into operation on Thursday 20th April 2023 and shall have an effect for 3 years thereafter, unless extended by further order as set out in the Act.

2. The Council is satisfied that the conditions set out in Section 59 (2) of the Act have been met. Namely, that activities carried out in a public place within the authority’s area have had or it is likely that they will have a detrimental effect on the quality of life of those in the locality

3. The Council is also satisfied that the conditions set out in Section 59 (3) of the Act have been met. Namely, that the effect or likely effect of the activities is, or is likely to be, of a persistent or continuing nature and that these activities are unreasonable and justify the restrictions imposed by this Order and that it is in all the circumstances expedient to make this Order for the purpose of reducing crime and/or anti-social behaviour in a public place.

Additional notes and definitions for the purpose of the Order

- **A person who habitually has a dog in their possession shall be taken to be in charge of the dog at any time unless at that time some other person is in charge of the dog;**
- **Placing the faeces in a receptacle on the land which is provided for the purpose, or for the disposal of waste, shall be sufficient removal from the land;**
- **Being unaware of the defecation (whether by reason of not being in the vicinity or otherwise), or not having a device for or other suitable means of removing the faeces shall not be a reasonable excuse for failing to remove the faeces**
- **“an authorised officer of the Authority” means an employee, partnership agency or contractor of Doncaster Council who is authorised in writing by Doncaster Council for the purposes of giving directions under the Order.**

Exemptions

Nothing in this order shall apply to a disabled person (within the meaning of the Equality Act 2010) whose disability restricts their ability to comply with the order and the dog is their guide dog or assistance dog.

Fixed penalty notices and offences

1. It is an offence for a person without reasonable excuse to engage in any activity that is prohibited by this Order, or to fail to comply with a requirement to which that person is subject by virtue of this Order.

2. In accordance with section 67 of the above named Act, a person found to be in breach of this Order is liable on summary conviction to a maximum penalty of a level 3 fine or to a Fixed Penalty Notice up to £100.

Appeals:

In accordance with section 66 of the Act, any interested person who wishes to challenge the validity of this Order on the grounds that the Council did not have the power to make the Order or that a requirement under the Act has not been complied with may apply to the High Court within six weeks from the date upon which the Order is made.
