# Open Consultation- Improving the way Ofsted Inspects Education

Ofsted are asking parents, carers, professionals and learners what they think about our proposals to improve education inspections and their new report cards for providers.

This consultation closes at: 11:59pm on 28 April 2025.

### In summary, they propose:

- **Report cards** these would give parents and carers more detailed information than the current reports, including a new 5-point grading scale to evaluate more areas of a provider's work and short summaries of what inspectors found.
- Education inspection toolkits this tool shows providers and inspectors the evaluation areas that they focus inspections on and how they will assess and grade providers.
- **Inspection methodology** changes to how they carry out inspection.
- Full inspections and monitoring inspections, state-funded schools they plan to end ungraded inspections of state-funded schools and change

- their monitoring programmes so that they can check that timely action is taken to raise standards.
- **Identifying state-funded schools causing concern** a new approach to how they will place a school into a category of concern.

# Check an Early Years Qualification (CEYQ) Service is Now Live

We announced in January that we were developing a digital tool to help Early Years (EY) managers check whether staff qualifications meet ratio requirements in England. Following final testing, we are pleased to announce that the **Check an Early Years Qualification (CEYQ) service** has now launched on <u>Check an early</u> years qualification - GOV.UK

By entering details such as the qualification name, awarding organisation, and course start date, managers will receive a clear outcome that can be printed for records.

This service simplifies qualification checks, saving time during recruitment and HR processes. It supports workforce planning, ahead of the expanded funded childcare entitlements by September 2025.

CEYQ is for EY managers only and currently covers UK qualification. Other users should continue using the <u>Early Years Qualifications List (EYQL)</u> to check their qualifications or seek guidance from <u>Ecctis</u>.

# DFE Update Charging Guidance – Provider communication with parents

A few providers and LAs have asked about communication with parents and whether it remains acceptable to promote the benefits of their offer to parents, for example the benefits of additional activities or their food offer. Providers are able to do this

within the guidance as long as they are mindful of any **impacts on access for disadvantaged families** and it is made clear to parents that charges are not mandatory. They may wish to agree termly arrangements with parents regarding additional hours, activities or consumables purchased to aid with business planning and provide for stability of income.

In general, we recognise that the increased clarity on charging following the recent High Court judgment and subsequent updated guidance may necessitate an adjustment in business models for some providers, though it is important to stress that there has been no change to the underlying law and DfE's position has always been that charges must not be mandatory or a condition of accessing an entitlement place. We would encourage LAs to take a supportive and pragmatic approach to supporting providers during any transition to compliance

The Department is not encouraging parents to opt out (as long as reasonable alternatives are offered for parents who do opt out, and the impact on disadvantaged parents is considered) and where providers are anxious about communicating with parents they may wish to use or align with the Childcare Choices Campaign's focus this term on how early years education supports children's development as well as helping families juggle family life a little easier.

We know that many providers have been reassured that once they've spoken to parents, parents have proved supportive regarding any changes necessitated by the updated guidance.

Here is the **Childcare Choices newsletter** that was sent to 270k parents last week which include a parent case study, sharing their story of how their provider celebrated World Book Day and how early years education supports their child's development: Final reminder to working parents: apply for your childcare code

## The EEF Guide to the Early Years Pupil Premium

The Education Endowment Foundation has released a guide to Early Years Pupil Premium and how this should be used effectively for children. The document is designed to support Early Years settings in making informed decisions about how to use their increased EYPP funding.

The guide – developed in consultation with early years leaders – recommends a balanced approach to spending and encourages settings to:

- Develop quality practice, including through investing in high-quality professional development.
- Tailor personalised support, including targeted interventions that meet children's specific needs.
- Lead, plan, and sustain, including supporting meaningful engagement between leaders and their teams so that changes to practice stick.

# Sensory Processing: What it is and why it matters- E-Learning Course

This e-learning introduces sensory processing: what it is and why it matters and is intended to be used by a wide variety of practitioners especially those working directly with Disabled Children and Young People and those with Special Educational Needs.

# Early Years: New to Role of SENCO

## **Outline**

It is a requirement of the Local Code of Practice that all group provisions have a named SENCO and that all SENCOs attend appropriate training. Ideally the setting SENCO should be a senior member of staff (Level 3 qualified with at least 2 years post qualification experience) working in a management role.

Before you attend the first session, please:

- Have an awareness the Special Educational Needs and Disability code of practice: 0-25 years (January 2015).
- Have an awareness of the Early Years: Guide to the 0-25 years SEND code of practice.
- Refer to the Statutory Framework for the Early Years Foundation Stage 2021 and note/highlight all references to SEND.

The course is run over two sessions which will take attendees from basic principles and practice, supporting high quality interactions and children's development, through to the enabling environment, and working with parents and professionals. There will be gap tasks for practitioners to carry out between the sessions. It is expected that the Nursery Manager will support and mentor the practitioner during these tasks.

Through attending this course you will be provided with tools and advice to develop the skills required to complete documentation and provide an appropriate environment for children. A pack of reference and support documents will be provided at the beginning of the course, which is to be brought to each of the sessions. Handouts will be provided at each session, but it is suggested that you also take notes for yourself.

## **Description**

Course content:

- Setting up a childminding business: registration with HMRC; recording income and expenditure; completing Tax Returns; marketing your business; undertaking market research; developing a business plan.
- Providing an enabling environment: looking at equipment and resources and how best to use these; activities and experiences that children should access.
- Learning and Development: discussion and example documents that can be used to record child observations, advice around planning children's next steps, learning how children are making progress; how/why you produce a 2 year Progress Report.
- Child development: a series of DfE online child development training sessions to complete at your own pace. The sessions will cover physical, cognitive and personal, social and emotional development of children.
- The Safeguarding and Welfare requirements of the EYFS: looking at and discussing the requirements in Section 3 of the EYFS: producing policies and procedures; how to safeguard your setting; legal documentation ie: contracts, records, insurance; discussion around what to expect during your Ofsted registration visit.
- Basic Awareness in Child Protection and Safeguarding Children: a child protection training course that enables identification, understanding and response to possible signs of abuse or neglect including discussion of the categories and signs of abuse; how to record incidents; reporting requirements; contact details for partner agencies.
