Notice is hereby given that on the 4th day of June 2025 the City of Doncaster Council made an Order under the provisions of the Road Traffic Regulation Act, 1984.

The effect of the Order that will come into operation on the 9th day of June 2025 will be to introduce a 20 mph speed limit on the following roads:

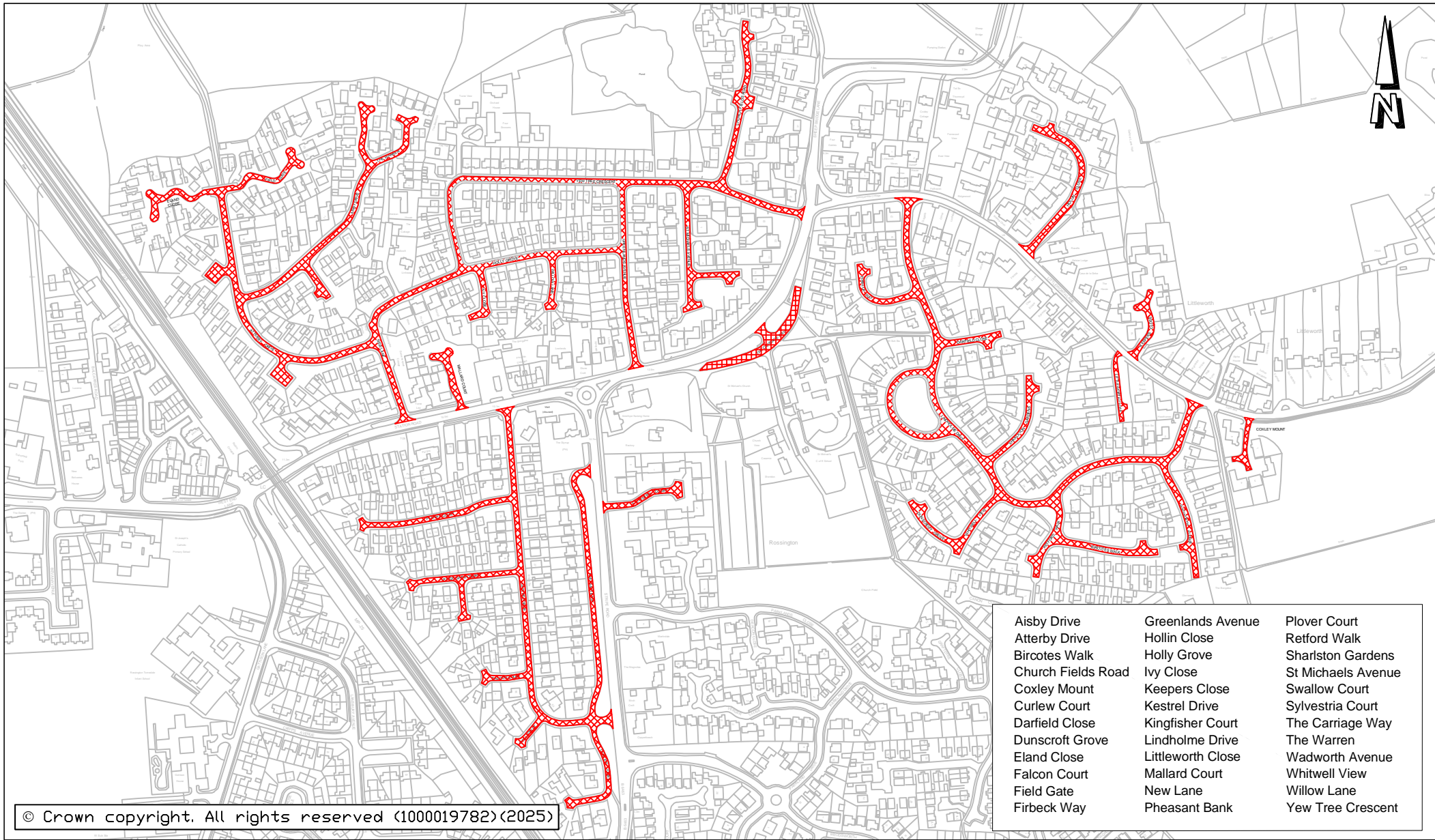
