Notice is hereby given that on the 1<sup>st</sup> day of October 2025 the City of Doncaster Council made an Order under the provisions of the Road Traffic Regulation Act, 1984.

The effect of the Order that will come into operation on the 13<sup>th</sup> day of October 2025 will be to:

(i) Remove the existing 20mph speed limit on the following road:

South End from its junction with West Street in a South Easterly direction to a point 66 metres east of Swanland Court

(ii) introduce a 20mph speed limit on the following road:

South End from its junction with West Street in a generally South Easterly direction to a point 165 metres east of Swanland Court

If you wish to question the validity of the Order or of any of the provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1984, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order you may within six weeks from the 1<sup>st</sup> day of October 2025 apply to the High Court for this purpose.

- 1. The City of Doncaster Council (Various Roads Doncaster) Speed Limits (Consolidation) Order 2011 shall have effect as though:-
- the following item was revoked in Schedule 1.01 of the Order 20 MPH Speed Limit: South End (from its junction with West Street in a south easterly direction to a point 66 metres east of Swanland Court)
- the following item was included in Schedule 1.01 of the Order 20 MPH Speed Limit:
  South End from its junction with West Street in a generally south easterly direction to a point 165 metres east of Swanland Court.
- This Order shall come into operation on the 13<sup>th</sup> day of October 2025 and be cited as the "City of Doncaster Council (Various Roads Doncaster) Speed Limits (Consolidation) Order 2011 (Amendment No. 150) Order 2025".
