That length of the **A631 Bawtry Road Tickhill** which extends from a point 490 metres southeast of its junction with Stripe Road to its junction with Bawtry Road in a generally southeasterly direction

That length of **Bawtry Road** from its junction with the A631 Bawtry Road to the borough boundary in a generally southwesterly direction

That length of the **A631 Tickhill Road Bawtry** which extends from its junction with Bawtry Road to a point 140 metres west of its junction with Oak Tree Road in a generally northeasterly direction



The City of Doncaster Council ("the Council") in exercise of its powers under Section 84 of the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with paragraph 20 of Part III of Schedule 9 of the Act hereby makes the following Order:-

1. The City of Doncaster Council (Various Roads Doncaster) Speed Limits (Consolidation) Order 2011 shall have effect as though the following items were included in Schedule 4.01 of the Order 50mph Speed Limit:-

That length of the A631 Bawtry Road Tickhill which extends from a point 490 metres southeast of its junction with Stripe Road to its junction with Bawtry Road in a generally southeasterly direction

That length of Bawtry Road from its junction with the A631 Bawtry Road to the borough boundary in a generally southwesterly direction

That length of the A631 Tickhill Road Bawtry which extends from its junction with Bawtry Road to a point 140 metres west of its junction with Oak Tree Road in a generally northeasterly direction

2 This Order shall come into operation on the day of 2025 and be cited as the "City of Doncaster Council (Various Roads Doncaster) Speed Limits (Consolidation) Order 2011 (Amendment No. ) Order 2025".
