Notice is hereby given that on the 6<sup>th</sup> day of March 2024 the City of Doncaster Council made an Order under the provisions of the Road Traffic Regulation Act, 1984.

The effect of the Order that will come into operation on the 18th day of March 2024 will be to:

(a) Revoke the following items in Schedule1.03 no waiting at any time:

Dakota Way

North Side

From its junction with the western kerbline of Airbourne Road for a distance of 33 metres in a westerly direction.

Dakota Way

South Side

From its junction with the eastern kerbline of Airbourne Road for a distance of 36 metres in a westerly direction

(b) Include the following items in Schedule1.03 no waiting at any time:

Airbourne Road, Lakeside

East side

From the end of the highway boundary at the Runway Park for a distance of 40 metres in a southerly direction

Dakota Way, Lakeside

North side

From its junction with the western kerbline of Airbourne Road for its entire length in a westerly direction

Dakota Way, Lakeside

South side


- (i) From its junction with the western kerbline of Airbourne Road for a distance of 46 metres in a westerly direction
- (ii) From the end of the highway boundary at the Aircraft Museum for a distance of 10 metres in an easterly direction

Exceptions to the Order will permit waiting for the purpose of picking up and setting down passengers, loading and unloading goods, in connection with building industrial or demolition operations, the removal of obstructions to traffic, the maintenance of the roads and the services therein in pursuance of statutory powers or duties, for the collection and delivery of postal packets or if it is a vehicle being operated by or on behalf of the South Yorkshire Safety Camera Partnerships while carrying out roadside monitoring or enforcement operations. The usual exceptions for disabled persons vehicles are also included in the Order

If you wish to question the validity of the Order or of any of the provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1984, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order you may within six weeks from the 6<sup>th</sup> day of March 2024 apply to the High Court for this purpose.

East side

From the end of the highway boundary at the Runway Park for a distance of 40 metres in a southerly direction

### Dakota Way, Lakeside

North side

From its junction with the western kerbline of Airbourne Road for its entire length in a westerly direction

South side
