

STATEMENT OF REASONS

The proposal is intended to add a car park charge to Bank Holidays and Public Holidays in off street car parks.

The proposal is intended to extend the car park operating hours to provide better use and enforcement of the car parks in the town centre, to add a parking charge and the cost for parking will improve the correct intended use of the car parks.

These proposals will allow a greater use and improved service and will not affect any traffic flow in any of the car parks in the order.

The proposal should be neither compromise road safety, visibility nor the free flow of traffic in Doncaster.

Notice is hereby given that City of Doncaster Council propose to make an Order under the provisions of the Road Traffic Regulation Act 1984 and all other enabling powers.

The effect of the proposed Order will be to:

- (a) Introduce a parking charge of £1.00 payable on Sundays, Bank Holidays and Public Holidays and remove the existing £0.00 charge, for a length of stay between the hours of 08:00 to 18:00 (all day parking) on the following parking places, Chamber Road Car Park, Church Way Surface Car Park, College Road Surface Car Park, New Markets Car Park, St Georges Car Park, and Wood Street Car Park;
- (b) Control and specify the conditions of use of the parking place, control the scale of charges, control the class of permitted vehicles and the times and days of operation, as set out in the Schedule to this Notice; and
- (c) To remove from the Shop and Collect Provision at New Markets Car Park.

(AMENDMENT NO.) ORDER 2024**

The City of Doncaster Council (hereinafter referred to as “the Council”) in exercise of its powers under Sections 32, 33 and 35 of the Road Traffic Regulation Act 1984 and Part 6 of the Traffic Management Act 2004 and all other enabling powers hereby makes the following Order: -

1. The City of Doncaster Council (Off Street Parking Places) Order 2018 shall have effect as though: -

(i) the following item was deleted from article 2 (1) of the Order: -

“Council” means the Doncaster Borough Council

and the following item was substituted in lieu thereof: -

“Council” means the City of Doncaster Council

(ii) the following item was deleted from article 2 (1) of the Order: -

“Shop and Collect Parking Bay” means an area of a parking place that is provided for the parking of a vehicle whilst the driver of the vehicle is using the shop and collect facilities and is indicated by symbols and or signage located within the boundaries of the parking bay;

(iii) the following item was deleted from article 3 (13) of the Order : -

Where within the parking place known as New Markets Car Park there is a sign or surface marking which indicates that a parking bay is a shop and Collect parking bay the driver of a vehicle shall not cause or permit it to wait in that parking bay unless the driver of the vehicle is actively using the shop and collect facilities. The driver of the vehicle shall not cause or permit the vehicle to wait for a period exceeding 10 minutes or return to that parking bay for a period of 30 minutes.

(iv) the following item was deleted from article 4 (11) of the Order : -

Without prejudice to Article 5(5) of this Order in respect of New Markets Car Park a vehicle parked in a Shop and Collect Parking Bay shall be exempt from payment specified in Article 6(1) of this Order for a maximum period of 10 minutes subject to the provisions of Article 3(13) of this Order.

(v) the following item was deleted from article 5 (5) of the Order: -

If, on the New Markets Car Park, a vehicle is left within a Shop and Collect Parking Bay and the driver of the vehicle is not actively using the Shop and Collect facilities or the driver of the vehicle has caused or permitted the vehicle to wait for a period that exceeds 10 minutes or returns within 30

minutes of leaving that parking bay in contravention of Article 3(13) of this Order then a penalty charge shall be payable by the driver of the vehicle.

(vi) the following item was deleted from article 6 (1)(i) of the Order:-

Shop and Collect Parking Bay

£0.00 pence for a period not exceeding 10 minutes only.

Mondays to Saturdays inclusive excluding Bank Holidays and Public Holidays other than Good Friday

and the following item was substituted in lieu thereof -

Mondays to Sunday inclusive of all Bank Holidays and Public Holidays

(x) the following item was deleted from the Third Schedule column 4 of the Order: -

Sundays only

and the following item was substituted in lieu thereof -

Sundays and all Bank Holidays and Public Holidays

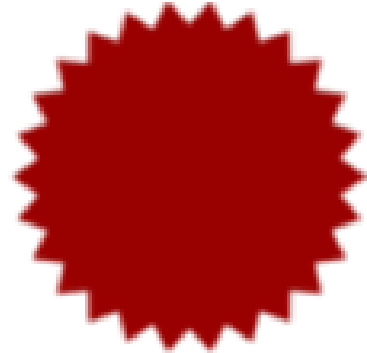

(OFF STREET PARKING PLACES)
ORDER 2018**

Doncaster Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Section 35 of the Road Traffic Regulation Act 1984 and Part 6 of the Traffic Management Act 2004 and all other enabling powers hereby makes the following Order: -

1 This Order shall come into operation on the 1st day of October 2018 and may be cited as the Doncaster Borough Council (Off-Street Parking Places) Order 2018.

2 (1) In this Order: -

"1984 Act" means the Road Traffic Regulation Act 1984;

"1991 Act" means the Road Traffic Act 1991;

"2004 Act" means the Traffic Management Act 2004;

"Article" means an Article of the Order unless otherwise stated and includes reference to any paragraph of that Article referred to by number or letter;

"Bank Holiday" means a day which is or is observed as a bank holiday or a holiday under the Banking and Financial Dealings Act 1971 or any statutory re-enactment or modification for the time being in force;

"Beechfield Permit" means a parking permit issued by the Beechfield Family Centre;

"Bus" means a motor vehicle as defined by the Traffic Signs Regulations and General Directions 2016;

"Business user permit" means a parking permit purchased from the Council pursuant to the provisions of Articles 6(9), 6(11) & 6(13) of this Order;

"Cashless Parking" means a method of payment by which the driver of the vehicle on arrival at the parking place registers the vehicle by contacting the Parking Service Manager by mobile phone or similar device to supply sufficient information regarding the details of the location of the parking place; the time of arrival at the parking place and the registration details of the vehicle will be recorded to allow the vehicle to park within the parking place in compliance with the provisions of this Order";

"charging hours" means any period specified in column 5 of the First Schedule to this Order in respect of which a charge is specified in Article 6 to this Order;

“Civil Enforcement Officer” means a person employed by the Doncaster Borough Council for the purposes of the enforcement (inter alia) of this Order;

“concessionary electronic daily ticket” means a parking ticket purchased electronically from the Council in furtherance of employment by the Council pursuant to the provisions of Articles 6(19) or 6(21);

“concessionary electronic permit” means a parking permit purchased electronically from the Council in furtherance of employment by the Council pursuant to the provisions of Articles 6(15) or 6(17);

“Council” means the Doncaster Borough Council;

“Disabled persons badge” as defined by the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000;

“Disabled persons parking bay” means any area of a parking place that is provided for the use of disabled drivers for the parking of a Disabled persons vehicle and is indicated by symbols and or signage located within the boundaries of the parking bay;

“Disabled persons vehicle” has the same meaning as defined by the 1984 Act;

“Driver” in relation to a vehicle waiting in a parking place means the person driving the vehicle at the time it was left in the parking place or the person deemed to be the driver under the terms of this Order;

“Electric Vehicle” means a Plug-in Electric Vehicle or a Plug-in Hybrid Electric Vehicle;

“Electric Vehicle Parking Bay” means an area of a parking place that is provided for the use of drivers of Electric Vehicles in order to recharge their vehicle by using the electric plug-in points in the car park and is indicated by blue lines, symbols and or signage located within the boundaries of the parking bay”;

“Electric Vehicle Charging Point” means a purpose built unit designed specifically for the charging of electric vehicles;

“Emergency Services Vehicle parking bay” means an area of a parking place that is provided for the parking of a liveried vehicle belonging to the emergency services and is indicated by symbols and or signage located within the boundaries of the parking bay;

“evening charging hours ” means any period specified in column 5 of the Second Schedule to this Order in respect of which a charge is specified in Article 6 to this order;

"Large Goods Vehicle" has the same meaning as defined in the Road Traffic Act 1988;

"invalid carriage" has the same meaning as defined by The Use of Invalid Carriages on Highways Regulations 1988 and used within the terms of those Regulations;

"owner" in relation to a vehicle means the person by whom such vehicle is kept and used;

"paragraph" means a paragraph or sub-paragraph of the Article in which the word appears;

"parking bay" means any area of a parking place which is provided for the leaving of a vehicle and indicated by markings on the surface of the parking place;

"parking place" means any area of land specified by name in column 1 of the First and Second Schedule to this Order provided by the Council under Section 32(1) of the 1984 Act for use as a parking place;

"Parking Services Manager" means an Officer for the time being appointed to that post by the Council;

"parking ticket" means a ticket indicating the payment of a charge and the date and time at which the charge was paid;

"Penalty Charge" means a charge set by the Council in accordance with guidance given by the Secretary of State under the provisions of the 2004 Act and specified in the Penalty Charge Notice;

"Penalty Charge Notice" means a Notice issued by a Civil Enforcement Officer pursuant to the provisions of the 2004 Act;

"Permit" means any Business user permit, season permit, concessionary electronic permit and concessionary electronic daily ticket issued by the Council;

"Relevant position" means:

- (a) In the case of a vehicle fitted with a front windscreen the parking ticket, disabled persons badge, Business user permit or season permit is exhibited thereon with the obverse side facing forwards on the nearside of and immediately behind the windscreen;
- (b) In the case of a vehicle not fitted with a front windscreen the parking ticket, disabled persons badge, Business user permit or season permit is exhibited in a conspicuous position on the front or nearside of the vehicle;

“season permit” means a parking permit purchased from the Council pursuant to the provisions of Articles 6(5) and 6(7) of this Order;

“Secretary of State” means the Secretary of State for Transport;

“Schedule” means a schedule of this Order unless otherwise stated;

“Shop and Collect Parking Bay” means an area of a parking place that is provided for the parking of a vehicle whilst the driver of the vehicle is using the Shop and Collect facilities and is indicated by symbols and or signage located within the boundaries of the parking bay;

“Specified parking charge” is defined in Article 6 of this Order;

“Term Time Only” means the Doncaster Metropolitan Borough Councils academic year;

“ticket machine” for the purpose of this Order means an apparatus designed to issue parking tickets indicating the payment of a charge and the date and time at which the charge was paid;

“Uniform” in relation to the 2004 Act means a mode of dress worn by a Civil Enforcement Officer as determined and supplied by the Parking Authority provided that such mode of dress shall at all times clearly identify that the wearer is engaged on parking enforcement duties for the Council and includes the personal identification number of the Civil Enforcement Officer;

“Valid Ticket” means a parking ticket which has not become invalid and is not being used in circumstances where it is not valid.

- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to an Act of Parliament

USE OF LAND AND PARKING PLACE

- 3 (1) Each area of land specified by name in column 1 of the First and Second Schedule to this Order may be used subject to the following provisions of this Order as a parking place for such classes of vehicles in such positions on such days and during such hours as are specified in relation to that area in that Schedule.
- 3 (2) Where in a Schedule to this Order a parking place is described as available for vehicles of a specified class or in a specified position the driver of a vehicle shall not permit it to wait in that parking place unless it is of the class and in the position so specified.
- 3 (3) Where within a parking place there is a sign or surface marking which indicates that a parking bay is available only for a disabled person's vehicle the driver of a vehicle shall not permit it to wait in that parking bay unless it is a disabled person's vehicle displaying a

current disabled person's badge.

- 3 (4) The driver of a vehicle shall not permit it to wait in a parking place for longer than the maximum period permitted for waiting specified in Article 6 of this Order.
- 3 (5) When a vehicle has left a parking place after waiting therein the driver thereof shall not within two hours after its leaving permit it to wait again in that parking place.
- 3 (6) Insofar as a vehicle is left in a parking place during either the charging hours period and/or the evening charging hours period the driver thereof shall pay such charge or charges as are specified in the following provisions of this Order.
- 3 (7) Any vehicle displaying an expired parking ticket or invalid permit shall not be left in a parking place.
- 3 (8) Nothing in sub paragraph 3(1) above shall restrict the power of the Council to close any parking place or part thereof at any time for such reasons as may be specified.
- 3 (9) The Council shall be entitled to suspend any or all of the provisions of this Order on such occasions and for such purposes as it thinks fit.
- 3 (10) Where within the parking place known as the College Road Surface Car Park (Formerly the Irish Club) there is a sign or surface marking which indicates that a parking bay is available only for "Private parking Monday to Saturday" the driver of a vehicle shall not permit it to wait in that parking bay unless the vehicle is displaying a current Beechfield Permit.
- 3 (11) Where within a parking place there is a sign or surface marking which indicates that a parking bay is available only for use by an Electric Vehicle the driver of a vehicle shall not permit it to wait in that parking bay unless it is an Electric Vehicle and the vehicle is being recharged at the Electric Vehicle Charging Point contained within that parking bay
- 3 (12) Where within a parking place there is a sign or surface marking which indicates that a parking bay is an Emergency Services Vehicle parking bay that bay is available only for a liveried vehicle belonging to the emergency services and the driver of a vehicle shall not permit it to wait in that parking bay unless it is a liveried vehicle belonging to the emergency services.
- 3 (13) Where within the parking place known as New Markets Car Park there is a sign or surface marking which indicates that a parking bay is a Shop and Collect Parking Bay the driver of a vehicle shall not cause or permit it to wait in that parking bay unless the driver of the vehicle is actively using the Shop and Collect facilities. The driver of the vehicle shall not cause or permit the vehicle to wait for a period

exceeding 10 minutes or return to that parking bay for a period of 30 minutes.

EXEMPTIONS TO PAYMENT OF CHARGES

- 4 (1) Without prejudice to Article 5(2) of this Order the driver of a disabled persons vehicle which displays in a relevant position a disabled persons badge shall be exempt from any payment specified in Articles 6(1) of this Order subject to the provisions of Article 18(1) of this Order provided that vehicle is parked in a marked disabled persons parking bay.
- 4 (2) A liveried vehicle belonging to the emergency services when on operational duties which is left in a parking place during the charging hours and/or evening charging hours shall be exempt from any payment specified in Article 6(1) to this Order.
- 4 (3) A liveried vehicle belonging to the emergency services which is left in a parking place during the charging hours and/or evening charging hours shall be exempt from any payment specified in Articles 6(1) of this Order provided that vehicle is parked in a marked Emergency Services Vehicle parking bay.
- 4 (4) A vehicle which displays in the relevant position a valid season permit that is left in a parking place specified in Articles 6(6) and 6(8) shall be exempt from any payment specified in Article 6(1) of this Order.
- 4 (5) A vehicle which displays in the relevant position a valid Business user permit that is left in a parking place specified in Articles 6(10), 6(12) and 6(14) shall be exempt from any payment specified in Article 6(1) of this Order.
- 4 (6) A vehicle with a valid concessionary electronic permit that is left in a parking place specified in Article 6(16) or 6(18) shall be exempt from any payment specified in Article 6(1) of this Order.
- 4 (7) A vehicle with a valid concessionary electronic daily ticket that is left in a parking place specified in Articles 6(20) or 6(22) shall be exempt from any payment specified in Article 6(1) of this Order.
- 4 (8) A liveried vehicle which is left in any parking place specified in Column 1 of the First or Second Schedule to this Order in furtherance of the drivers employment by the Council or with St Leger Homes and is left in the parking place while the driver undertakes duties in relation to the Council or St Leger Homes during the operational hours specified in that Schedule shall be exempt from the provisions of this Order.
- 4 (9) Without prejudice to Article 5(3) of this Order in respect of the College Road Surface Car Park (formerly the Irish Club) a vehicle which displays in the relevant position a valid Beechfield Permit issued by Beechfield Family Centre shall be exempt from any

payment specified in Article 6(1) of this Order when the vehicle is left in a parking bay available only for a vehicle displaying a current Beechfield Permit and having a surface marking which indicates that the parking bay is available only for "Private Parking Monday to Saturday".

- 4 (10) Without prejudice to Article 5(4) of this Order an Electric Vehicle left in an Electric Vehicle Parking Bay shall be exempt from payment specified in Article 6(1) of this Order for a maximum period of 3 hours subject to the provisions of Article 18(2) of this Order. Thereafter the provisions of Article 3(6) of this Order shall be applied.
- 4 (11) Without prejudice to Article 5(5) of this Order in respect of New Markets Car Park a vehicle parked in a Shop and Collect Parking Bay shall be exempt from payment specified in Article 6(1) of this Order for a maximum period of 10 minutes subject to the provisions of Article 3(13) of this Order.

CIRCUMSTANCES IN WHICH A PENALTY CHARGE WILL BE PAYABLE

- 5 (1) If a vehicle is left in a parking place during the charging hours and/or the evening charging hours either:-
- (i) for a longer period than that for which a payment was made;
 - (ii) without a valid Parking Ticket or Permit being displayed;
 - (iii) if a vehicle other than a Disabled persons vehicle displaying a Disabled persons badge in the relevant position is parked in a parking bay marked as available only for a Disabled persons vehicle;
 - (iv) returning within two hours of leaving the same parking place in contravention of Article 3(5) of this Order;
 - (v) if the vehicle is left in a parking place other than wholly within a marked parking bay;
 - (vi) if the vehicle is a large goods vehicle;
 - (vii) In respect of the New Markets Car Park, if the vehicle is a coach and is left in that parking place for a period which exceeds 30 minutes;

- (viii) if the vehicle is a coach, subject to the provisions of Article 5(1)(vii);
 - (ix) if a vehicle, other than an Electric Vehicle, is left in a parking bay marked as available only for an Electric Vehicle
 - (x) if a vehicle, other than a liveried vehicle belonging to the emergency services, is left in a parking bay marked as available only for an Emergency Services Vehicle.
- 5 (2) If a Disabled persons vehicle, displaying a Disabled persons badge in the relevant position, is left in a parking place other than in a marked Disabled persons parking bay then the penalty charge shall be payable by the driver of the disabled persons vehicle.
- 5 (3) If, on the College Road Surface Car Park (Formerly the Irish Club), a vehicle displaying in the relevant position a valid Beechfield Permit is left in the parking place other than in a bay having a surface marking which indicates that the parking bay is available only for "Private Parking Monday to Saturday" then the penalty charge shall be payable by the owner of the vehicle.
- 5 (4) If an Electric Vehicle is parked in an Electric Vehicle Parking Bay and the vehicle is not actively using the Electric Vehicle Charging Point then a penalty charge shall be payable by the driver of the Electric Vehicle.

REFUND OF CHARGE IN CONNECTION WITH THE ISSUE OF ANY PERMIT

- 6 (26) (i) A permit holder who surrenders to the Council any permit before the permit becomes valid shall, provided that they have given to the Council a notice of ten (10) working days, be entitled to a refund of any charge paid in respect of the issue thereof
- (ii) A permit holder who surrenders a permit to the Council after the permit has become valid shall, provided that they have given to the Council a notice of ten (10) working days, be entitled to a refund of that part of the charge paid in respect of the issue of the permit as is attributable to the period from receipt by the Council of the surrendered permit to the expiry of the period for which the permit was issued

PENALTY CHARGE AND PAYMENT

- 7 (1) In the case of a vehicle in respect of which a Penalty Charge is payable under the provisions of Article 5, 18(1) and 18(2) of this Order a Penalty

Charge Notice may be issued by a Civil Enforcement Officer in accordance with the requirements of the 2004 Act

- 7 (2) A Penalty Charge Notice shall contain the details required by the 2004 Act
- 7 (3) Where a Penalty Charge Notice has been issued the Penalty Charge Notice shall be payable by the owner of the vehicle in respect of which the Notice was issued in accordance with the 2004 Act
- 7 (4) The Penalty Charge shall be paid to the Council in the manner specified in the Notice referred to in Article 7(1) of this Order

RESTRICTION OF REMOVAL OF NOTICES

- 8 When a Notice has been attached to a vehicle in accordance with any of the foregoing provisions of this Order no person other than a person authorised by the Council in that behalf or the driver or a person authorised by the driver in that behalf shall remove the Notice from the vehicle

OTHER PROVISIONS

- 9 Pursuant to powers given for the purpose in Sections 35(A) of the 1984 Act the following shall apply:-
 - (i) if on the date a vehicle is left in a parking place a person is shown to have been the Registered Owner or Keeper thereof in writing from the Vehicle Registration Authority then for the purpose of this Order and any legal proceedings in relation thereto it shall be conclusively presumed (notwithstanding that such a person may not be an individual) that he was the driver of the vehicle at that time and accordingly that acts or omissions of the driver of the vehicle at that time were his acts or omissions unless the Registered Keeper can prove that at the relevant time the vehicle was in the possession of some other person without his consent or that he was not the owner of the vehicle
 - (ii) the date and time printed on any parking ticket from a ticket machine at a parking place shall be good evidence in any legal proceedings in relation to this Order that the parking ticket was purchased on that date and at that time
10. The driver of a vehicle shall not permit that vehicle to wait in a parking place unless the vehicle is licensed in pursuance of the provisions of the Vehicle Excise and Registration Act 1994 or other statutory re-enactment and there is in place in relation to the use of the vehicle by the driver such policy of insurance as complies with the requirements of Part VI of the Road Traffic Act 1988 or other statutory re-enactment
11. The driver of a vehicle using a parking place shall stop the engine as soon as the vehicle is in position in the parking place and shall not start the

engine except when about to change the position of the vehicle in or to depart from the parking place

- 12 (1) No person shall use a vehicle while it is in a parking place in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skill or services
- 12 (2) No person shall use any part of a parking place or any vehicle left in a parking place -
 - (i) for sleeping or camping or cooking or
 - (ii) for the purpose of servicing or washing any vehicle or part thereof other than is reasonably necessary to enable that vehicle to depart from the parking place
13. The driver of a vehicle using a parking place shall not sound any horn or other similar instrument except when about to change the position of the vehicle in or to depart from the parking place
- 14 (1) If a vehicle is left in a parking place in a position other than in accordance with the provisions of Article 3 of this Order a person authorised by the Council in that behalf may alter or cause to be altered the position of the vehicle so that its position is in accordance with the said provisions
- 14 (2) If a vehicle is left in a parking place in contravention of any of the foregoing provisions of this Order a person authorised by the Council in that behalf may remove the vehicle from that parking place or arrange for such removal
- 14 (3) For the purpose of meeting the requirements of an emergency a person authorised in that behalf by the Council or a police constable in uniform may alter or cause to be altered the position of a vehicle in a parking place or remove or arrange for the removal of a vehicle from a parking place
- 14 (4) Any person altering or causing the alteration of the position of a vehicle or removing or causing the removal of a vehicle may do so by towing or driving the vehicle or in such other manner as he may think reasonably necessary to enable the position of the vehicle to be altered or the vehicle to be removed
- 14 (5) Any person removing or arranging for the removal of a vehicle shall make such arrangements as he considers to be reasonably necessary for the safety of the vehicle in the place to which it is removed
- 15 Where in a parking place signs are erected or surface markings are laid for the purpose of: -
 - (i) indicating the entrance to or exit from the parking place or

- (ii) indicating that a vehicle using the parking place shall proceed in a specified direction within the parking place

No person shall drive or permit to be driven any vehicle (i) so that it enters the parking place otherwise than by an entrance or leaves the parking place otherwise than by an exit so indicated or (ii) in a direction other than so specified

- 16 No person shall except with the permission of a person authorised by the Council in that behalf drive or permit to be driven any vehicle in a parking place for any purpose other than the purpose of leaving that vehicle in the parking place in accordance with the provisions of this Order or for the purpose of departing from the parking place
- 17 Where, in the parking place, signs are erected or surface markings are laid for the purpose of indicating disabled person's parking bays, the driver of a disabled person's vehicle, which is displaying a current disabled person's badge, parks the said vehicle in one of the said bays provided shall be exempt from any payments provided specified in Articles 6 and 7 of this Order
- 18 (1) A disabled persons vehicle which is parked in a parking bay other than a marked disabled person's parking bay shall not be exempt from any payment specified in Articles 6 and 7 of this Order.
- 18 (2) A Electric Vehicle which is parked in a parking bay other than in a marked Electric Vehicle Parking Bay shall not be exempt from any payment specified in Articles 6 and 7 of this Order.
- 19 Where in the parking place signs are erected or surface markings are laid for the purpose of indicating motor cycle bays the rider of a motor cycle shall park in one of the bays provided for a maximum length of stay specified in Article 6 of this Order for that car park and shall be exempt from any payment in the bays provided as specified in Articles 6 and 7 of this Order
- 20 No vehicle shall be left in a parking place other than in a position indicated by a sign or by white lines on the surface of the parking place and in particular no vehicle shall be left in a parking place in such a position so as to obstruct the entrance thereto or the exit there from nor in such a position so as to prevent the driving away of any vehicle already in a parking place or in such a position so as to cause an obstruction to other vehicles
- 21 The Council may suspend the operation of this Order or any provision of the Order on any day at any time when any area of land specified in column 1 of the First and/or Second Schedule to this Order is required in connection with any official function or business of the Council or on account of any security reasons or for any other purpose whatsoever
- 22 No person shall in any parking place wantonly shout or otherwise make any loud noise to the disturbance or annoyance of users of the parking place or residents of premises in the neighbourhood

- 23 No person shall in any parking place use threatening abusive or insulting language gesture or conduct with intent to put any person in fear or so as to occasion a breach of the peace or whereby a breach of the peace is likely to be occasioned

DISPOSAL OF VEHICLES ON PARKING PLACES

- 24 Pursuant to powers given for the purpose in Sections 99 and 101 of the 1984 Act the Council may sell or otherwise dispose of, in such manner as they think fit any vehicle that has been or could at any time be removed from a parking place in pursuance of Article 14 of this Order

Provided that the power of disposal conferred by this Article shall not be exercisable unless the Council has taken such of the following steps as are applicable to the vehicle and there has elapsed a period of six weeks beginning with the taking of the first of those steps

- 25 (1) Subject to the provisions of Article 31 of this Order where a vehicle carries a registration mark issued under the Vehicle Excise and Registration Act 1994 the Council shall ascertain in writing from the Vehicle Registration Authority the name and address of the person who it appears is the owner of that vehicle
- 25 (2) For the purposes of Articles 24 and 26 the first steps shall be taken to be the sending of the notice mentioned in Article 28
- 26 The Council shall send by recorded delivery service a notice to the address of the person who by virtue of Article 25 of this Order appears to be the owner of the vehicle stating that it is the intention of the Council to sell or otherwise dispose of the vehicle (which shall be sufficiently described in the notice) on or after the specified date (which shall not be less than two weeks from the date of the notice and in any event not earlier than six weeks from the date of the first step taken by the Council under this Part of this Order) unless it is in the meantime removed by or on behalf of that person from such place as may be specified by the Council in the said notice or from such other place as may be subsequently notified in writing by the Council to that person
- 27 If any person to whom a notice is sent in accordance with Article 26 of this Order informs the Council of the name and address of some other person who he alleges may be the owner of the vehicle a notice stating the particulars mentioned in Article 26 shall be sent by recorded delivery service to that other person and to any further person who the Council may in consequence of the sending of the notice to the said other person be led to believe may be the owner of the vehicle
- 28 Subject to the provisions of Article 31 of this Order where a vehicle does not carry a registration mark issued under the Vehicle Excise and Registration Act 1994 the first step to be taken by the Council shall be to apply in writing to the Chief Officer of the Police Force in whose area is the parking place from which the vehicle has been or could at any time be removed inquiring who that Officer considers is the owner of the vehicle and the address of that person

- 29 If after steps have been taken under the foregoing provisions of this Part of this Order a vehicle is not claimed the Council shall make such further inquiries (if any) as it considers reasonable as to who may be the owner of the vehicle and the address of that person
- 30 Where by virtue of Articles 28 and 29 of this Order the Council is informed of the name and address of a person who it considers may be the owner of the vehicle Articles 26 and 27 of this Order as respects the sending of notices shall apply in relation to the person
- 31 Nothing in the foregoing provisions in this Part of the Order shall require the Council to take any such steps as is therein mentioned for the purpose of inquiring who is the owner of a vehicle to which Article 24 of this Order applies if the Council has found a person who it is satisfied is in fact the owner of that vehicle and a notice in the manner and containing the particulars specified in Article 26 of this Order has been sent to him at his address the sending of the notice being treated as the first step for the purposes of that Article and Article 24
- 32 The Council shall apply the proceeds from any vehicle sold under the provisions of this part of this Order in or towards the satisfaction of any costs incurred in connection with the disposal thereof and of any charge to payment of which the Council is entitled as regards the vehicle under the provisions of the Act
- 33 In the event of any such costs incurred by the Council in connection with the disposal of the vehicle not being satisfied by virtue of Article 32 of this Order the Council may recoup those costs so far as not satisfied from the person who was the last owner of the vehicle before it was removed from the parking place either in pursuance of Article 14 of this Order or after it has been disposed of by virtue of the power of disposal conferred by Article 24 of this Order except in a case where that person satisfies the Council that he was not responsible for the vehicle being in the place from which it was removed and in that case the person by whom the said cost shall be payable shall be the person driving the vehicle at the time it was left in that place
- 34 Any sums received by the Council on the sale of the vehicle after deducting any sum applied thereto by virtue of Article 32 of this Order shall be payable to any person who satisfies the Council within a period of one year from the date of the sale of the vehicle that but for such sale the vehicle would have belonged to him and insofar as any such sums are not claimed within the said period they shall be retained by the Council

RIGHT OF OWNER TO RECOVER VEHICLE OR PROCEEDS FROM SALE OF VEHICLE

- 35 (1) Pursuant to Section 101A of the 1984 Act if before a vehicle is disposed of by the Council pursuant to the provisions of Section 101 of the 1984 Act and under the provisions of Article 24 of this Order it is claimed by a person who;
- (a) satisfies the Council that he is its owner and,

(b) pays the relevant charges

the Council shall permit him to remove the vehicle from its custody within such period as the Council may specify

- 35 (2) If before the end of the period of one year beginning with the date on which a vehicle is sold by the Council under Section 101 of the 1984 a person satisfies the Council that at the time of the sale he was the owner of the vehicle the Council shall pay him any sum by which the proceeds of sale exceed the amount of the relevant charges specified below;
- (i) any penalty charge payable in respect of the parking of the vehicle in the place from which it was removed; or
 - (ii) such unpaid earlier penalty charges relating to the vehicle as may be prescribed; and
 - (iii) such sums in respect of the removal and storage of the vehicle as the Council may require in accordance with Section 9 of the 2004 Act
- 35 (3) In any other case the relevant charges are such sums in respect of the removal and storage of the vehicle as may be prescribed
- 35 (4) If in the case of any vehicle it appears to the Council that more than one person is or was its owner at the relevant time such one of them as the Council thinks fit shall be treated as its owner for the purposes of this section
- 36 The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under either the 1984 Act or the 2004 Act or by or under any other enactment.
- 37 The Orders shown in the Third Schedule to this Order are hereby revoked
