The City of Doncaster Council ("the Council") in exercise of its powers under Section 84 of the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with paragraph 20 of Part III of Schedule 9 of the Act hereby makes the following Order:-

1. The City of Doncaster Council (Various Roads Doncaster) Speed Limits (Consolidation) Order 2011 shall have effect as though the following items were included in Schedule 1.01 of the Order 20 MPH Speed Limit:-

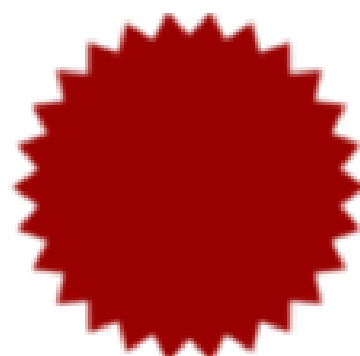
Warmsworth

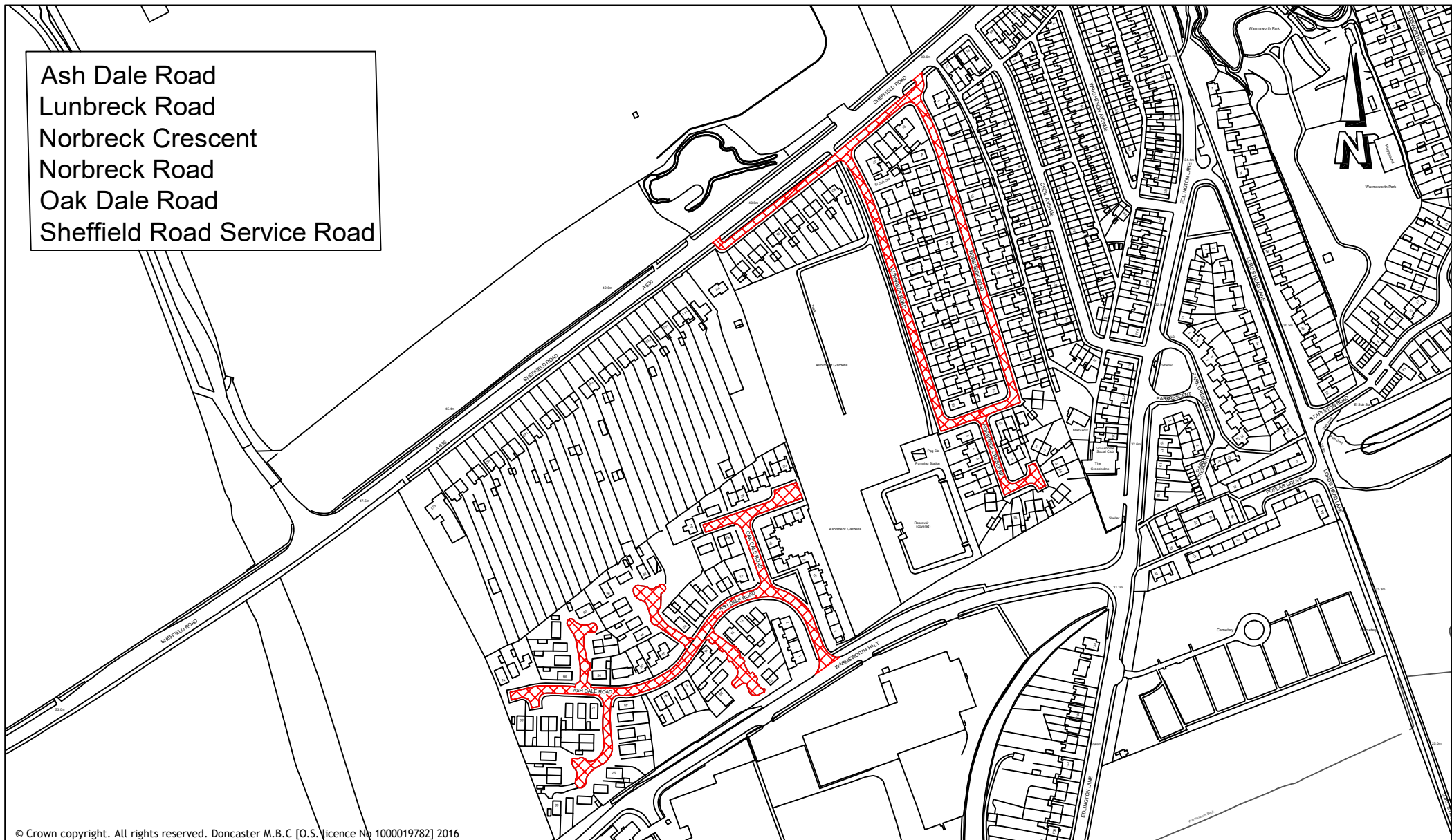

SHEFFIELD ROAD SERVICE ROAD (From Norbreck Road to its boundary with 105)
